<b>Infrastructure</b>	<ul style="list-style-type: none"> <li>• Protect existing and future transportation corridors and do not allow incompatible uses within them</li> <li>• Provide infrastructure in a coordinated, efficient and cost-effective manner to meet projected needs</li> <li>• Sufficient land is to be made available to meet projected needs for a time horizon of up to 20 years, except where an alternate time period has been established by a provincial plan</li> </ul>	<ul style="list-style-type: none"> <li>• Strengthen the protection for provincially planned transportation corridors and promote land use compatibility for lands adjacent to planned and existing corridors   <b>Policy 1.6.8</b></li> <li>• Support the adaptive re-use of infrastructure and require consideration of life-cycle cost of infrastructure (e.g., through asset management planning)   <b>Policies 1.6.1, 1.6.3</b></li> <li>• Planning for infrastructure/public service facilities can extend beyond 20 years   <b>Policy 1.1.2</b></li> </ul>

<b>Climate Change</b>	<ul style="list-style-type: none"> <li>• In settlement areas, land use patterns are to be based on densities and a mix of land uses that minimize negative impacts to air quality and climate change</li> <li>• Indirectly supports climate change by promoting compact built form, intensification, stormwater management, public transit and alternative transportation, and alternative/renewable energy</li> </ul>	<ul style="list-style-type: none"> <li>• Require the consideration of potential impacts of climate change (e.g., flooding due to severe weather) to support the reduction of greenhouse gas emissions and adaptation to climate change   <b>Policy 1.8</b></li> <li>• Encourage green infrastructure (e.g., permeable surfaces) and strengthen stormwater management requirements   <b>Policies 1.6.2, 1.6.6.7</b></li> </ul>

<b>Mineral Aggregate Resources</b>	<ul style="list-style-type: none"> <li>Protects some natural heritage features/areas from extraction while extraction in other features requires demonstration of no negative impact</li> <li>Permits extraction of mineral aggregate resources in prime agricultural areas as an interim use provided that rehabilitation will be carried out</li> </ul>	<ul style="list-style-type: none"> <li>Require identification of mineral, petroleum, and mineral aggregate resources, where provincial information is available   <b>Policies 2.4.2, 2.5.1</b></li> <li>Support the conservation of mineral aggregate resources, including through the use of accessory aggregate recycling facilities at extraction sites (e.g., pits and quarries), wherever feasible  <b>Policy 2.5.2.3</b></li> <li>Strengthen requirements for rehabilitation of aggregate extraction sites in specialty crop areas and further limit extraction below the water table in specialty crop areas   <b>Policy 2.5.4.1</b></li> <li>Promote comprehensive rehabilitation planning, and require mitigation of negative impacts wherever possible as part of progressive and final rehabilitation   <b>Policy 2.5.3.1, 2.5.3.2</b></li> </ul>
<b>Natural Hazards</b>	<ul style="list-style-type: none"> <li>Development shall be directed away from hazardous areas such as flood-prone areas and unstable slopes</li> </ul>	<ul style="list-style-type: none"> <li>Require the consideration of the potential impacts of climate change (e.g., flooding due to severe weather) that may increase the risk associated with natural hazards   <b>Policy 3.1.3</b></li> <li>Development shall generally be directed away from areas of high-to-extreme risk of wildland fire unless the risk is mitigated   <b>Policy 3.1.8</b></li> </ul>
<b>Aboriginal</b>	<ul style="list-style-type: none"> <li>No reference to Aboriginal interests</li> </ul>	<ul style="list-style-type: none"> <li>Recognize Aboriginal interests in land use planning   <b>Vision</b></li> <li>Promote the conservation of cultural heritage and archaeological resources, including the use of archaeological management plans and cultural plans   <b>Policy 2.6.4</b></li> </ul>
